

## The Future of the Region: the Spatial Development Strategy

#### Overview

We are developing a **Spatial Development Strategy** (SDS) to make sure our region remains a thriving, successful and innovative place for the future. The plan will make sure the development of homes, spaces for employment and transport links happens in the right places giving all residents access to opportunities and a better quality of life. It will help us meet our aim to be carbon neutral by 2030 and ensure that nature and wildlife can also benefit.

The SDS will cover Bath and North East Somerset, Bristol and South Gloucestershire and will be developed by those councils and the West of England Combined Authority. **North Somerset** will develop their Local Plan in cooperation with the WECA authorities but will not be included in the SDS.

#### The scale of the challenge

The West of England's population is growing. People are attracted to move to the region and our resident population is increasing. House prices and rents are rising and, as people live longer, the amount and types of housing that are needed is changing.

Over the next 20 years the area covered by the Spatial Development Strategy could need around 88,500 or as many as 125,000 homes (depending on the Government's method of calculating housing need, linked to the national housing target).

However, we will need to consider constraints and opportunities to arrive at the right amount of homes to plan for (which may or may not reach these numbers).

#### Generating employment and a clean, resilient economy

The coronavirus pandemic has changed lives, businesses, work and travel patterns. The SDS can help us build back a more clean, inclusive economy through providing the space and infrastructure needed for residents to access good jobs, and for businesses to thrive. This will support growth, drive innovation and support clean and low carbon sectors.

#### Why we are consulting

Your views will help us shape the Spatial Development Strategy so we can create a better place to live, work and play.

The survey runs from 2 November to 14 December 2020. An engagement report and responses will be published online in early 2021.

The SDS will identify opportunities for new housing and employment development and ensure it is supported by the right infrastructure. It will also acknowledge other factors such as Green Belt, protected areas, and what can be delivered.

#### What is the Green Belt?

The Green Belt is land designated around urban areas to maintain the open nature of land and prevent urban sprawl. It is designated based on five criteria set out in national policy:

- 1. to check the unrestricted sprawl of large built-up areas;
- 2. to prevent neighbouring towns merging into one another;
- 3. to assist in safeguarding the countryside from encroachment;
- 4. to preserve the setting and special character of historic towns;
- 5. to assist in urban regeneration, by encouraging the recycling of derelict and other urban land

A case may be made for reviewing the existing extent of the Green Belt in exceptional circumstances. Green Belt review happens through the plan making process.
